

# İÜYÖS-2019 GUIDE FOR ENROLMENT TO ISTANBUL UNIVERSITY

**Dates of Registration: Monday, 2 September 2019- Friday, 6 September 2019**

International students need to get their registration done at the student affairs office of the related faculties/schools in person. No documents delivered by post is accepted. (If it is not possible to apply for the registration in person, the registration of those candidate student can be carried out by a representative or deputy with a written procuration if their excuse is found valid by the related institution).

## **Required Documents for the Enrolment**

- a. The original high school diploma or interim certificate of graduation with a notarized Turkish translation from a Notary Public or Turkish Embassy abroad.
- b. The original Diploma Equivalence Certificate given by the Turkish Ministry of Education Provincial Directorate for National Education or Turkish Foreign Representatives (Candidate students who have been applied to Provincial Directorate of National Education in Turkey and could not get the diploma equivalency between registration dates can be registered conditionally if they have a registration/application document given by the Provincial Directorate of National Education in Turkey.

*Students must submit their diploma equivalency to the student affairs office of the related department of Istanbul University within 60 days of the enrolment date. Otherwise their enrolment will be cancelled.)*

- c. Transcripts, showing the names of the courses, grades received for the courses and grade point average, approved by the administration of the candidate's high school with a notarized Turkish translation approved by a Notary or Turkish Embassy abroad.
- d. The GCE AL result report with a notarized Turkish translation approved by a Notary or Turkish Embassy abroad for the candidates who have TRNC citizenship, reside in TRNC, have completed secondary education TRNC and have obtained GCE AL degrees and those who have or will have GCE AL degree after registering and getting education in the colleges or high schools in other countries between 2005 – 2010.
- e. The printout of the İÜYÖS exam result.
- f. The copy of passport pages which shows visa, identity information and passport's period of validity and Turkish translation of pages approved by notary or Turkish Foreign Representative.
- g. If available, the copy of internationally recognized Foreign Language Proficiency Exam Result Report or Turkish Language Proficiency Exam Result Report approved by notary or Turkish Foreign Representative, if any.
- h. Residence Document (Student must submit it to their student affairs office within one month after the registration).

- i. 8 photographs in 4,5×6,0 cm (within the last six months, from the front face, the photograph should be taken in a way that the candidate can easily be recognized).
- j. The bank receipt showing the tuition fee is paid.
- k. Signed Financial Guarantee Document. For the form [CLICK HERE](#).
- l. Candidates who change their citizenship to Turkish should provide the copy of Family Status Registration Document.

- The registration of students who submit falsified, counterfeit, incomplete or incorrect documents for application, placement and/or registration, will be annulled even if final registration was done.
- Students registered at Istanbul University can submit their application for residence permit at <https://e-ikamet.goc.gov.tr/Ikamet/Basvuru/IlkBasvuru>
- International students of the Faculty of Open and Distance Education are not required to obtain a residence document/permit.
- The registered foreign or overseas students may have general health insurance if they apply to and pay for general health insurance premiums in three (3) months after the registration. For the general health insurance, apply to the Social Security Institution (SGK) in Istanbul.
- Those candidate students who fail to apply for registration within the specified dates of registration. lose their right of enrolment

- Those candidates who have although been placed in a specific program but failed/unable to being registered cannot apply to any program during the second placement.
- The İÜYÖS exam results is valid only for one (1) year for Istanbul University and therefore the candidates cannot use their score for the next year to apply for programs in Istanbul University.
- Istanbul University does not accept any other result of International Student Exam (YÖS) carried out by different institutions of higher education other than İÜYÖS in order to apply for its programs.
